

CALL FOR BIDS – TRAVEL AGENCY AND FLIGHT SERVICES

The Berghof Foundation is seeking to engage service providers to enter into corporate framework agreements to provide reliable, high-quality travel support services throughout Somalia and the wider region. It is the intention to conclude with a corporate framework agreement for at minimum one year, which can be extended upon mutual agreement. Prices and services offered in the quotation will constitute the fixed¹ payable rates and conditions for any flight bookings and service orders placed during 2026-27. Adjustment to the pricing due to changing conditions are eligible upon mutual negotiation. The organization does not guarantee a minimum volume of business. Actual bookings will be confirmed via individual purchase orders.

All interested and qualified bidders are invited to submit their offer by filling in the bidder's form provided by the Berghof Foundation below or provide their own standard corporate agreement and price listing indicating all services specified in the bidders' form.

Evaluation Criteria & awarding procedure

Please note that the evaluation of bidders along with the final conclusion of the corporate framework agreement will be based on a selection of criteria indicating sufficient provision of items and services in addition to economic consideration, including:

- ☐ Price defined as the basic rates and variations for single-trip and round-trip regional and continental flights. All rates are preferably indicated in USD.
- ☐ Qualifying characteristics defined as the overall quality of provisional resources and services in compliance with the applicable laws ("suitability"). The criteria used for the purpose of assessing the overall quality include:
 - Visa Support Services: Logistical support in facilitating visas for Somali nationals to low threshold countries of interest, including Kenya, Djibouti, and Ethiopia.
 - Reliable Communication & Information sharing: Access to information and ability to book local and regional flights.

The evaluation of the criteria will be conducted using a scoring matrix (max. 100 points) in a 50:50 split between the price and the qualifying characteristics. Within the qualifying characteristics, each sub criteria a maximum score of 2 x 25 points can be achieved.
